<b>BELGIUM – FLEMISH SPEAKING COMMUNITY</b>	
<ol style="list-style-type: none"> <li>1. Applications must be submitted in Dutch, French or English; if otherwise, original version + translation into Dutch required. If the translation is not provided, the application will be considered ineligible.</li> <li>2. Normally only one Flemish organisation per Grundtvig Learning Partnership (except when there is a clear added value / complementarities) and one Learning Partnership per organisation will be accepted. For large organisations such as a CVO with more than 385.000 teaching hours, 2 applications/projects are possible if these Learning Partnerships deal with different target groups &amp; themes. For a CVO with more than 740.000 teaching hours 3 applications/projects are possible provided these Learning Partnerships deal with different target groups and themes.</li> <li>3. Organisations are only eligible if they can prove to have a clear and existing link with the adult education sector (as meant in the Grundtvig programme) in the Flemish Community.</li> </ol>	None

Organisations are only eligible if they can prove to have a clear and existing link with the adult education sector (as meant in the Grundtvig programme) in the French Community.</li> <li>2. Only one Belgian (French Community) organisation per Grundtvig Learning Partnership and one Learning Partnership per Belgian (French Community) organisation will be accepted. If more than one organisation is involved in the same partnership, all the partners will be considered as ineligible.</li> <li>3. <b>BULGARIA</b>	
<p>1. Only one Bulgarian organisation can participate in one partnership, regardless of its status in the partnership – coordinator or partner. If more than one organisation is involved in the same partnership, all Bulgarian organisations will be considered ineligible. Only one application for Grundtvig Learning Partnerships can be submitted by each Bulgarian organisation, regardless of its status in the partnership – coordinator or partner. If an organisation submits more than one proposal for Grundtvig Learning Partnerships, all project proposals submitted by it will be considered ineligible.</p> <p>2. In case an organisation with a valid Grundtvig Learning Partnership agreement submits another application, it will be regarded as ineligible, unless the new application has been submitted in the year when the running project phases out.</p> <p>3. If the applicant organisation is not a public organisation and is pre-registered under the Trade Register Law, the organisation must indicate its Unified Identity Code (BULSTAT code). <b>CYPRUS</b>	
<p>1. Only one Cypriot organisation can participate in each Grundtvig Learning Partnership. If more than one Cypriot organisation is involved in a single partnership, all partners from Cyprus will be considered ineligible.</p> <p>2. Only one application either for Grundtvig Learning Partnerships or Leonardo da Vinci Partnership per organisation will be permissible. If an organisation submits more than one application, the National Agency will let the organisation decide which application should be put forward. In case an organisation with a valid Grundtvig Learning Partnership or Leonardo da Vinci Partnership agreement submits another application, it will be regarded as ineligible,</p>	None

<b>CZECH REPUBLIC</b>	
<p>1. Only one application for Grundtvig Learning Partnerships per organisation will be permissible. (In the case of universities or other higher education institutions, each faculty is eligible to submit its own application.) Local/regional branches of national organisations established by law will be considered as independent organisations. If an organisation submits more than one application, the NA will go back to the applicant organisation and let it choose which application should be put forward. Should the applicant fail to do it in the time limit set by the National Agency, all the applications submitted by the applicant will be considered ineligible.</p> <p>2. Applications from organisations involved in Grundtvig Learning Partnerships which are currently still running will be considered ineligible.</p> <p>3. A maximum of two Czech organisations are eligible in the same Grundtvig Learning Partnership. If more than two Czech organisations are involved in the same partnership, all Czech partners in that partnership will be considered ineligible.</p>	None

Furthermore, each organisation may only have one valid Grundtvig Learning Partnership agreement at a time. In case an organisation with a valid Grundtvig Learning Partnership agreement submits another application, it will be regarded as ineligible, unless the new application has been submitted in the year when the running project phases out.</li> <li>2. Broad participation of learners and staff in partnership activities is required, i.e. at least 10 persons actively involved from the Danish organisation.</li> <li>3. If an application is drafted in another language than English or Danish, the applicant must submit both the original application and a translation into English or Danish. <b>ESTONIA</b>	
<ol style="list-style-type: none"> <li>1. Only one application for a Grundtvig Learning Partnership per organisation will be permissible. If an organisation submits more than one application, the National Agency asks the applicant to choose which application should be put forward. Larger organisations (with more than 500 staff members) can submit more than one application if they are dealing with different groups and topics or involve different departments within the organisation.</li> <li>2. Only one organisation from Estonia, which has no on-going Grundtvig or Leonardo da Vinci partnerships, is eligible in the Grundtvig Learning Partnership. If more than one Estonian organisation is involved in a single application, the National Agency will ask the Estonian organisations to decide which of them will withdraw its application.</li> <li>3. The same person cannot be the legal representative and/or contact person for more than one Grundtvig Learning Partnership corresponding to the same call for proposals.</li> </ol>	<ol style="list-style-type: none"> <li>1. <b>SPAIN</b>

Only one application per organisation for a Grundtvig Learning Partnership and only one organisation from Spain in the same Grundtvig Learning Partnership will be permissible.</li> <li>2. The same person cannot be the contact person/ responsible for the development of more than one Learning Partnership corresponding to the same call for proposals, either in the same institution or in different organisations.</li> <li>3. Private applicant organisations must prove and give details through legal (*) relevant</li> </ol>	<ol style="list-style-type: none"> <li>1. Maximum two applications from an organisation from Finland for a Grundtvig Learning Partnership and only one organisation from Finland in the same Grundtvig Learning Partnership will be permissible. If more than two applications from a Finnish organisation are involved in the same partnership and if more than one organization is involved in the same partnership, all Finnish partners in that partnership will be considered ineligible.</p>	<p>None</p>
<b>FRANCE</b>

An organisation can submit only one application for a Grundtvig Learning Partnership. If an organisation submits more than one application, it will be asked to choose one of them to put forward. <p><b>CROATIA</b></p>	
<p>1. Only one organisation from Croatia will be eligible in the same Grundtvig Learning Partnership. If more than one organisation is involved in the same partnership, they will all be considered ineligible.</p> <p>2. Two applications for Grundtvig Learning Partnerships per organisation will be permitted. If an organisation submits more than two applications, the National Agency will go back to the applicant and let it choose which application should be put forward.</p> <p>3. If the application is drafted in another language than English, the applicant must submit both the original application and a translation into English. If the translation is not provided, the applicant will be asked to deliver the translation; should the applicant fail to do this by the date specified by the NA, the application will be considered ineligible.</p>	<p>None</p>
<p><b>HUNGARY</b></p>	
<p>1. Only one on-going project Grundtvig Learning Partnership per organisation regardless the role (coordinator or partner) will be accepted.</p> <p>2. Higher education institutions can apply by faculties. One application / faculty can be accepted. One higher education institution can have maximum 3 agreements in one project round.</p> <p>3. If one organisation submits two or more Grundtvig Learning Partnership applications at the same time, they will be given the choice which one to keep and which one(s) to withdraw. In case an organisation with a valid Grundtvig Learning Partnership agreement submits another application it will not be considered, unless the new application is submitted in the year when the on-going project phases out.</p>	<p>1. Applications submitted by non-profit organisations (5 points)</p> <p>2. Applications from applicants with an 'active' Grundtvig Learning Partnership will be considered ineligible.</li> <li>2. Only one application for a Grundtvig Learning Partnership per organisation will be accepted. If an organisation submits more than one application, the National Agency will request that the organisation decide which application should be put forward for selection. Larger organisations can submit more than one application if they are dealing with different groups or involve different departments within the organisation.</li> <li>3. A broad participation of learners and staff in the partnership activities is required, i.e. at least 10 persons actively involved from the Irish organisation.</li> </ol>	None
<b>ICELAND</b>	
<ol style="list-style-type: none"> <li>1. Only one application from the same institution for Grundtvig Learning Partnership will be allowed per year. If an organisation submits more than one application, the National Agency will ask them to prioritise their applications. This rule does not apply for larger institutions (20 staff members or more). Larger institutions can submit up to 2 applications if the thematic/subject areas and target groups are different.</li> <li>2. The applicants must submit a brief presentation of their organisation and its activities in the field of adult learning, be it formal, non-formal or informal.</li> <li>3. Broad participation of learners and staff in partnership activities is required i.e. at least 10 persons actively involved from the Icelandic organisation.</li> </ol>	1. Priority will be given to applications that focus on disadvantaged groups, young unemployed people, and disabled people. (10 points)
<b>ITALY</b>	
<ol style="list-style-type: none"> <li>1. Only one Partnership application per organisation will be accepted. The legal representative will take full responsibility in signing a declaration to confirm that a single application has been submitted. In case of an organisation submitting more than one application, the NA will contact the applicant and ask to choose which application should be put forward.</li> </ol>	None

An organisation can submit only one Grundtvig Learning Partnership application involving not more than one Lithuanian organisation in the same partnership. If an organisation is already participating in a Grundtvig Learning Partnership, it can submit another application for Partnership only in its second year of implementation. The National Agency will accept only one Grundtvig Learning Partnership application per organisation and per contact person. <b>MALTA</b>	
<p>1. Only two Grundtvig Learning Partnership applications per organisation will be accepted. If an organisation submits more than two applications, the NA will contact the applicant and ask it to choose which applications should be put forward. Organisations with more than 1000 learners can submit three applications. In all cases, applications have to deal with different target groups (which need to be clearly indicated by the applicant.)</p> <p>2. A maximum of two Maltese organisations are eligible in the same Grundtvig Learning Partnership. If more than two Maltese organisations are involved in a single partnership, all Maltese partners will be considered ineligible.</p> <p>3. The applicant is requested to provide a filled-in Financial Identification sheet with the institution's bank account details. This sheet has to be presented with the application form.</p>	<p>1. Priority will be given to partnerships addressing the use of statistics in education, with particular relevance to the measurement of adult competencies.</p> <p>2. Priority will be given to partnerships addressing the issue of recognition and validation of knowledge and skills obtained as a result of informal and non-formal learning.</p> <p>3. <b>NETHERLANDS</b>	
<p>1. The Dutch National Agency will accept at the most one Grundtvig Learning Partnership application per organisation (or per organisation unit/department, in the case of larger-sized organisations with several branches). If an organisation submits more than one application, the National Agency will contact the applicant, who can then decide which application should be kept.</p> <p>2. The Dutch National Agency will accept at the most two Dutch organisations per Grundtvig Learning Partnership. <b>PORTUGAL</b>	
<ol style="list-style-type: none"> <li>1. Restriction on the number of applications: A maximum of one Grundtvig Partnership application per institution will be accepted. If an institution submits more than one application, the National Agency shall contact the applicant and ask that one of those applications be chosen to be put forward. The remaining application(s) shall be rejected under this criterion.</li> <li>2. Restriction on the number of Portuguese institutions in the same partnership: Only two organisations/institutions. <b>ROMANIA</b>	
<ol style="list-style-type: none"> <li>1. Only one application can be submitted per organisation. If an organisation submits more than one application, the National Agency will go back to the applicant and let it choose which application should be put forward. If the applicant fails to do it in the time limit set by the National Agency, all the applications submitted by this organisation will be considered ineligible and rejected. Larger organisations (for example the universities) can submit more than one application if they involve different departments/ faculties within the organisation.</li> <li>2. If the application is drafted in another language than English or French, the applicant must submit both the original application and a translation into Romanian. If the translation is not provided together with the original application form, the application is considered as ineligible and rejected.</li> <li>3. If the applicant is a private institution (including NGOs) the institution has to add to the application a Certificate obtained from the appropriate financial administration which attests that the institution has not debts. Only one application per organisation will be accepted for an organisation with up to 1000 learners and only two applications per organisation for an organisation with more than 1000 learners if the applications are targeted towards different groups. If a Grundtvig Learning Partnership includes more than one organisation from Slovenia, all Slovene applicants will be considered ineligible.</li> <li>2.
